C. High School Completion Status

Provide one of the following documents that indicate the student's high school completion status when the student will begin college in 2020–21:

- · A copy of the student's high school diploma.
- · A copy of the student's final official high school transcript that shows the date when the diploma was awarded.
- A copy of the student's General Educational Development (GED) certificate, an official GED transcript that indicates the student passed the exam, or a state-authorized high school equivalent certificate.
- For students who completed secondary education in a foreign country, a copy of the "secondary school leaving certificate" or other similar document.
- A state certificate or transcript received by a student after the student passed a State authorized examination that the State recognizes the equivalent of a high school diploma (GED test, HiSET, TASC, or other Stated-authorized examination).
- An academic transcript that indicates the student successfully completed at least a two-year program that is acceptable
 for full credit toward a bachelor's degree.
- For a homeschooled student from a state where state law requires the student to obtain a secondary school completion credential for homeschool (other than a high school diploma or its recognized equivalent), a copy of that credential.
- For a homeschooled student from a state where state law does not require the student to obtain a secondary school completion credential for homeschool (other than a high school diploma or its recognized equivalent), a transcript or the equivalent, signed by the student's parent or guardian, that lists the secondary school courses the student completed and includes a statement that the student successfully completed a secondary school education in a homeschool setting.
